Use of Your Data Website Visitors

Like most website operators, Cathy Cheshire LLC collects non-personally-identifying information of the sort that web browsers and servers typically provide, such as the browser type, language preference, referring site, and the date and time of each visitor request. Cathy Cheshire LLC's purpose in collecting non-personally identifying information is to better understand how Cathy Cheshire LLC's visitors use its website. Occasionally, Cathy Cheshire LLC may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Cathy Cheshire LLC also collects potentially personally-identifying information like Internet Protocol (IP) addresses. Cathy Cheshire LLC does not use such information to identify its visitors, however, and does not disclose such information, other than under the same circumstances it uses and discloses personally-identifying information, as described below.

Gathering of Personally Identifying Information

Certain visitors to Cathy Cheshire LLC's website choose to interact with Cathy Cheshire LLC in ways that require Cathy Cheshire LLC to gather personally-identifying information. The amount and type of information that Cathy Cheshire LLC gathers depends on the nature of the interaction. For example, we ask those making purchases to provide their name and email address for the purpose of account creation. Cathy Cheshire LLC collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with Cathy Cheshire LLC. Cathy Cheshire LLC does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat it may prevent them from engaging in certain website-related activities.

Aggregated Statistics

Cathy Cheshire LLC may collect statistics about the behavior of visitors to its website. For instance, Cathy Cheshire LLC may reveal how many downloads a particular file got, or say which lessons are most popular. However, Cathy Cheshire LLC does not disclose personally-identifying information other than as described below.

Protection of Certain Personally-Identifying Information

Cathy Cheshire LLC discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors, and affiliated organizations that (i) need to know that information in order to process it on Cathy Cheshire LLC's behalf or to provide services available at Cathy Cheshire LLC's website, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using Cathy Cheshire LLC's website, you consent to transferring such information to them. Cathy Cheshire LLC will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors, and affiliated organizations, as described above, Cathy Cheshire LLC discloses potentially personally-identifying and personally-identifying information

only when required to do so by law, or when Cathy Cheshire LLC believes in good faith that disclosure is reasonably necessary to protect the property or rights of Cathy Cheshire LLC third parties, or the public at large. If you are a registered user of a Cathy Cheshire LLC website and have supplied your email address, Cathy Cheshire LLC may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Cathy Cheshire LLC and our products. If you send us a request (for example via a support email or via one of our feedback mechanisms), we reserve the right to publish it to help us clarify or respond to your request or to help us support other users. Cathy Cheshire LLC takes all measures reasonably necessary to protect against the unauthorized access, use, alteration, or destruction of potentially personally-identifying and personally-identifying information.

Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Cathy Cheshire LLC uses cookies to help Cathy Cheshire LLC identify and track visitors, their usage of Cathy Cheshire LLC website, and their website access preferences. Cathy Cheshire LLC visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Cathy Cheshire LLC's website, with the drawback that certain features of Cathy Cheshire LLC's website may not function properly without the aid of cookies.
